

Guest Policy

Guest access at PSC will only be available to persons who are legally able to possess a firearm. PSC Guests must be in compliance with all federal, state and local laws concerning ownership and handling of firearms. Guest access may be revoked at the sole discretion of PSC.

I certify as follows: (1) that I am not and have never been the subject of a criminal or any other proceeding that prevents me from legally owning, handling or possessing firearms under California or Federal law; (2) that I can lawfully own, handle and possess a firearm; and, (3) that all information I am providing is true and correct.

All guests (regardless of age) shall be required to conduct a safe handling demonstration with PSC staff prior to being allowed access to the firing range.

I have read, I understand and I agree to comply with the Terms and Conditions attached to this Guest Policy as well as the Release, Assumption of Risk and Indemnity Agreement and the Code of Conduct.

Additional Terms and Conditions

The cost of a guest pass is \$20 and it is good for access for the entire day. Assuming the Member has no guest credits remaining on their account, this fee may be paid by the guest directly, or alternatively will be automatically charged to the sponsoring member's card on file.

Any guest may be permitted to utilize the shooting range up to 3 times in a 12 month period.

All Guests are subject to the general policies and rules of operation and administration by PSC, all of which are intended to provide a safe, professional, friendly and family-oriented club.

Any Member or Guest of a Member may be suspended or expelled from the range and/or facility for violation of the Code of Conduct or for behavior deemed unsafe by PSC personnel. Decisions of PSC regarding suspension or expulsion are final.

Any destruction of PSC property caused by a Member's Guest, whether accidental, negligent, or willful or otherwise, may result in the violator being removed from the range and/or facility, and/or criminally prosecuted. In addition, PSC reserves the right to assess to the Guest a reasonable charge for any such damage.

Guests must allow PSC staff to make a copy of or take a picture of the Guest's drivers license, or other legal form of identification, and maintain that information for PSC records.

RELEASE, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

I,, on behalf of myself, my heirs and assigns, hereby acknowledge that I have
voluntarily applied to enter on to and to engage in and/or observe shooting and other activities at the Shooting Range Facility
which is called Placer Sporting Club ("PSC"). These activities include, but are not limited to, the use and discharge of firearms, and
the services and training by employees of PSC.

I acknowledge and understand that shooting activities are inherently hazardous and involve both known and unanticipated risks which could result in damage or destruction of property and physical or emotional injury, including paralysis or death, of myself or of other persons. These risks include, but are not limited to: being shot by or shooting myself or others; partial or total loss of eyesight or hearing; inhalation or other harmful contact with lead or other contaminants; and being struck by flying or falling objects. I further understand that the discharging of firearms and the use of ammunition have inherent dangers that cannot be fully eliminated, regardless the amount of care, instruction, or expertise.

I further acknowledge and understand that PSC is an indoor shooting facility which utilizes a series of component parts, including a bullet trap to decelerate discharged ammunition. I understand that these component parts and bullet traps may cause ricochets which could cause serious personal injury or death. I understand that PSC makes no warranty as to the design, manufacture, condition or fitness for any particular purpose of any facilities or equipment, including, but not limited to: firearms, ammunition, eye/ hearing protection, and first-aid supplies.

I represent that I am experienced and skilled in the proper handling, loading, use and discharge of all firearms and ammunition I intend to use at PSC, or if I am not, I will take an introduction to firearms course offered by PSC or affiliated company, prior to discharging a firearm on the firing range. I understand that PSC is specifically relying on the truth of my representations concerning my experience with firearms, in permitting me to make use of the facility.

I represent that I have never been convicted of a felony in any of the 50 United States.

▲ WARNING - PROPOSITION 65 WARNING & ACKNOWLEDGMENT: Entering the PSC shooting range facility can expose you to chemicals, including lead and lead compounds, known to the State of California to cause cancer, birth defects or other reproductive harm. I acknowledge and agree that PSC has explicitly advised me that by entering the PSC shooting range facility that I can be exposed to chemicals, including lead and lead compounds, known to the State of California to cause cancer, birth defects or other reproductive harm, and I freely assume all risks, injuries, or damages, known or unknown, of any type or nature whatsoever, from any such exposure.

I agree to assume full responsibility for any and all risks, injuries, or damages, known or unknown, of whatsoever any kind and nature, which I might incur as a result of entering PSC, using its facilities and equipment, and in engaging in or observing shooting and other activities.

I agree to abide by PSC's Code of Conduct.

I knowingly, voluntarily and expressly waive any and all claims I, my next of kin, heirs, guardians, representatives, assigns or any other person claiming under me completely and without reservation that I may have against Placer Sporting Club, its agents, officers, members, employees, instructors, volunteers, or representatives from any and all injuries or damages that I may sustain as a result of me entering the facility, using PSC equipment, or engaging in or observing shooting range activities. Also, I, my next of kin, heirs, guardians, representatives, assigns or any other person claiming under me, forever release, waive, discharge and covenant not to sue PSC, its agents, officers, members, employees, instructors, volunteers, or representatives for any personal injury, death, disability, property damage, property theft or acts and/or omissions of whatsoever kind and nature, including acts and/or omissions of other participants or persons at the facility.

I further acknowledge and agree that it is my understanding and intent that this Agreement, and any signed written amendments or modifications to it, shall remain in full force and effect from the date of execution and ever after shall be applicable to each and every occasion that I enter PSC or use its facilities or equipment or engage in or observe shooting and other activities.

I have carefully read this "Release, Assumption of Risk and Indemnity Agreement" and fully know its contents. I acknowledge that no other inducement, assurance or guarantee has been made to me in consideration of my signing this Agreement which I sign voluntarily and of my own free will. I further acknowledge and agree that this Agreement may be amended or modified only by a writing signed by me and by an authorized agent of the PSC.

Code of Conduct

- 1. Children must be at least 10 years old and be able to shoot over bench in a safe manner, in the sole judgment of Placer Sporting Club (PSC) personnel. Any exceptions will require explicit approval from PSC management.
- 2. Minors under the age of 18 must be accompanied by a parent or legal guardian who will sign a waiver and remain by their side at all times in the range.
- 3. Firearms will only be uncased or removed from the holster at the shooting station. Firearms will NEVER be transported between the table at back of range, and the shooting stations, unless properly cased and secured.
- 4. It is your responsibility to know and understand how to operate your firearm safely and ensure your firearm is in good working order.
- 5. Eye and Ear protection is mandatory for anyone entering the range, and for the duration of time on the firing range.
- 6. Always keep the firearm action open, magazines removed and only load when ready to commence firing.
- 7. Always keep your finger off the trigger and outside the trigger guard until you are ready to commence fire.
- 8. Fire only when safe conditions exist: all shooters must stand in their respective stall behind the bench.
- 9. Always keep firearms pointed down range in a safe direction.
- 10. Do not transfer uncased firearms from lane to lane.
- 11. Do not pass firearms directly from person to person. Place the firearm on the table (at shooting shooting station), and allow the next person to pick it up.
- 12. Only shoot at the target that is located directly in your lane.
- 13. The following types of ammunition are not allowed to be shot at PSC: tracer, incendiary, steel cased/core or aluminum cased. (Brass/Nickel cased defensive ammunition is allowed).
- 14. Any handgun caliber larger than .45 ACP or rifle chambered to .308 and above must be declared and approved by PSC Staff prior to entering the range.
- 15. Use only the correct ammunition for your firearm as recommended by the manufacturer.
- 16. Any firearm not being legally carried as concealed must be transported unloaded in a case or bag to or from the range.
- 17. If carrying a concealed weapon, which must be done in accordance with all state and local laws and with an active CCW permit, the firearm(s) shall remain concealed at all times within the facility, except while at the firing station.
- 18. Shooters who desire to shoot from the holster must be "holster qualified" through PSC instructors or affiliate.
- 19. Upon the command "CEASE FIRE", stop all shooting immediately, put down your firearm and back away from the firing line. Shooters may not re-approach the firing line or pick up any firearm until a Placer Sporting Club Range Safety Officer gives the "all clear" signal.
- 20. Never be under the influence of, or consume any alcohol or drugs, before or while shooting.
- 21. Food, drink, gum or any tobacco product is not permitted inside the range. Always remember to wash your hands immediately after leaving the range.
- 22. If you observe any unsafe conditions, report them to a range safety officer immediately, and if none are available please report to the nearest PSC staff member.
- 23. Discharging a firearms is a serious act with serious ramifications if not done safely and responsibly treat it as such!
